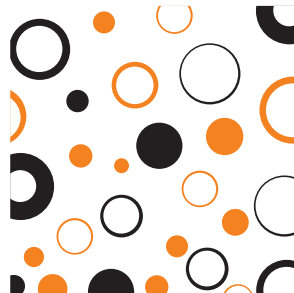

WHAT ARE THE PURCHASING REQUIRMENTS

CUSTOM PAPER

ACCENT PAPER - MINIMUM 15 SHEETS PER ITEM NUMBER

Accent papers include spots, cheveron, stripes etc. Sheet minimum is per item number and all sheets are the same color, text and image. All 15 sheets are exactly the same print.



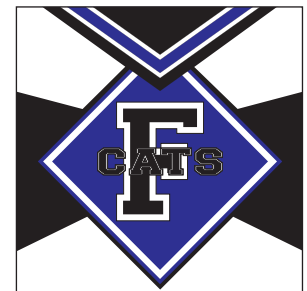
GENERAL PAPER - MINIMUM 10 SHEETS PER ITEM NUMBER

General papers include papers with mascot names, mascots images and other general school such as graduation or classes. General papers also include sports papers non specific to school or team name. All 10 sheets are exactly the same print.



SPECIFIC PAPER - MINIMUM 5 SHEETS PER ITEM NUMBER

Specific papers include papers specific to team, sport or activity. Specific papers also include all papers that are specific to school, city, town or state name. All 5 sheets are exactly the same print.

HOW DO I PLACE AN ORDER

After your wholesale application is processed you will receive a log in for our site www.gloverstamp.com. Shop the website and add your products to your cart. As specific items are designed for your account these items will be added to the website for you to shop. You will be provided with a code to enter that will calculate your discount amount. After all products are designed and quantities verified your order will be charged and shipped.

HOW IS MY ORDER SHIPPED

Product is shipped complete via Fed Ex or UPS with the appropriate insurance amount added. You can provide your own Fed Ex or UPS account number to ship your order. If you provide this account number for your shipment a \$7.50 handling fee will be added to your order total. The total on your web order will include any shipping charges, these charges will be removed if an account number is provided and used.

HOW DO I CREATE CUSTOM PRODUCT FOR MY STORE

Custom items are created by our design team using the databases shown on the website. Custom items are created and proofs are emailed to you for approval prior to production. Databases include ink colors, fonts, images and mascots.

WHAT IS THE LEAD TIME ON CUSTOM ORDERS

Lead time can vary on custom paper orders & chipboard book orders. Once product is designed and approved orders are usually shipped within 1 to 2 business weeks.
